
Merry Christmas and Happy Holidays!

HOA Reminders



Your adherence to the Chelsea Woods deed restrictions is greatly appreciated by all residents. As a reminder our deed restrictions do not allow for temporary structures per article 7 "No structure of a temporary character, mobile home, trailer, basement, tent, shack, garage, barn or other outbuilding shall be used on any lot at any time, as a residence or for protection of recreational vehicles either temporarily or permanently."

However, article 8 does allow for the installation of sheds, etc with written approval from the architectural committee "Any temporary building such as a utility shed, green house, or boat cover, etc. shall be constructed of materials similar to the house construction. Any temporary building must also receive the Architectural Control Committee's approval, as per paragraph #4"

Residents with structures that fall into a violation of these requirements, that are visible from the street should work to correct any violations. Should you have questions please fee free to contact us directly. Notices will be issued in the spring for any outstanding structures that are not in compliance with the deed restrictions.
